AG Ambrin: Sabah's success can be a benchmark for others

KOTA KINABALU: The auditor-general has praised the Sabah state government under the leadership of Chief Minister Datuk Seri Musa Haji Aman for its excellent financial performance.

The state government maintained its 'certificate without reprimand' for its financial statement for 12 years in a row from 2000 to 2011 and last year, it also achieved a good financial performance.

"It is among the best in the country and for certain, Sabah's success can be a role model or benchmark for other government departments and agencies," Tan Sri Ambrin Buang said at the presentation of Excellent Financial and Management Awards based on the Accountability Index of the National Audit Department 2011 here yesterday.

have filed their financial statements earlier than the fixed deadline.

"I have been told that so far, almost all state agencies in Sabah submitted their financial statements for 2011 to the Audit Department and most of them obtained the certificate without reprimand.

"Based on our record, 40 such certificates were issued to state agencies in Sabah for the 2010 financial year and from January 2011 till June 2012:

"This shows that the state government is responsive to the demand of financial governance," he stressed.

According to Ambrin, the number of Sabah agencies obtaining four-star rating has also increased significantly - from three in 2010 to six in 2011 and they were the State Secratariat, State Public Service Department, State Treasury, Government Printers, Kudat Town Board and Rural Development Corporation.

The Treasury Department, he said, suc-And, Ambrin also noted that state agencies ceeded in maintaining a four-star rating for four

years consecutively - from 2008 to 2011.

In 2011, he said 106 state agencies and departments were audited and each had shown that their financial management was at a good level.

He also said based on the achievement in 2011, the implementation of the accountability index rating has helped to create a work culture based on good practices and healthy competition.

"This shows that the government's endeavour to enhance integrity and accountability in the public service has been achieved. It also proves that achieving excellence in financial management is not something that is impossible," Ambrin said.

Ambrin also said as the government and public administration were constantly adopting good governance, he felt that it was important that all heads of department, agencies and state-owned companies ensure there was no delay in submitting their respective financial statements.

"Perhaps, the state government could make this the KPI for them," he said.

And, on excellent work culture, Ambrin stressed the need for civil servants to improve their capability in planning, implementing and monitoring state programmes and projects to ensure they were "value for money" and have a positive outcome for the good of the people in Sabah.

Meanwhile, the auditor-general said excellence in performance is a must for each and every member of the country's civil service.

"Every sen that belongs to the goverment must be managed responsibly and carefully to prevent any misappropriation which could anger the people. This is why there are rules which must be complied with to ensure there are checks and balances," he said.

Also present at the event officiated by the Chief Minister vesterday were State Secretary Tan Sri Sukarti Wakiman, Finance Ministry's permanent secretary Datuk Pengiran Hassanel Pengiran Mohd Tahir and heads of departments.
