Kelantan MACC: Lowest bribe recorded last year was RM152

KOTA BARU: Bribery is an offence regardless of the amount. Kelantan Malaysian Anti-Corruption Commission (MACC), in revealing annual statistics yesterday, said the lowest bribe it recorded was RM152 in a case from last year. Kelantan MACC director Rosli Husain said a man offered Immigration enforcement officers the bribe as an inducement to prevent the detention of several undocumented immigrants in Gua Musang. "We will not tolerate any amount. A bribe is a bribe." He said the man was arrested and hauled to court. He said seven civil servants had been arrested this year for accepting bribes. "They were detained in several locations in the state in a series of anti-graft operations between January and this month. Four have been charged in court."

GOVT FAILS TO FORFEIT RM114_M

Investigating officer failed to establish a money trail to prove cash came from unlawful activities, rules court

HE government has failed in its bid to forfeit RMI14 million in cash that was seized by the police during a raid at the Pavilion Residences in 2018, soon after the fall of the then prime minister Datuk Seri Najib Razak's-led Barisan Nasional administra-

tion. High Court judge Datuk Muhammad Jamil Hussin ruled the Attorney-General's Cham-bers had failed to prove that the money originated from 1Malaysia Development Bhd (1MDB), or was

obtained from a criminal breach of trust offence. However, he did not rule on the

release of the money which is kept inside Bank Negara Malaysia's vault, causing confusion to both parties.

sion to both parties.

Earlier, Jamil in his decision,
said the investigating officer
failed to establish a money trail to
prove that the cash originated
from unlawful activities.

"He (investigating officer) also failed to identify the person who has the power to control 1MDB funds.

"Furthermore, there is no evidence to show several sums of the RM114 million were converted into foreign currencies.

"The witnesses said they only spent the cash that they received without mentioning anything about converting the monies to other foreign currencies," he

Deputy public prosecutor Mo-hd Saifuddin Hashim Musaimi then applied for a stay of exe-

cution pending a written appeal.

He said the court also needed to determine other issues concerning the cash as the case involved

"They have thrown various allegations against me... they said I misused the money, I am a rob-ber, and a rogue which had tar-nished my reputation as a leader.

'Today (yesterday), it was

proven that all the malicious and slander allegations against me are false," he said. The government wanted to for-

feit RM114.164.393.44 in cash and jewellery, and high-end fashion items seized from the premises owned by Obyu Holdings Sdn

Bhd.
They alleged the money and items were linked to IMDB.
The prosecution had contended that Najib had allegedly received a total of US\$971 million, said to be 1MDB's money, from 2011 to 2013, and that the money seized from the condo was part of the illicit funds.

Besides the money, the raid also yielded 12,000 pieces of jewellery, valuable watches and expensive handbags.

MEAT CARTEL SCANDAL

6 MAQIS OFFICERS TO FACE CHARGES

A cold storage company manager is also expected to be charged today, says the MACC

IX Malaysian Quarantine and Inspection Services Department (Maqis) enforcement officers and a cold storage company manager are expected to be charged over the meat cartel fiasco.

The Malaysian Anti-Corruption Commission (MACC) said that they would be charged at the Sessions Court here this morning.

Ing.
The New Straits Times and Berita Harian previously reported that a cartel had been importing non-certified meat and selling them as halal meat in Malaysia.

Another Malay daily also broke the news on its operations in Johor.

The cartel has reportedly been operating for over 40 years and imported meat from non-halal-certified slaughterhouses in a few countries, such as Brazil, Bolivia, Canada, Colombia, Spain and Mexico.

The meat, smuggled out of the port, would be taken to ware-houses where it would be mixed with halal-certified meat, repacked with fake halal logos and then sold in the market.

A total of RM6.47 million worth of uncertified meat was seized by the authorities.

On April 23, a company, including its two directors and manager, was charged in the Sessions Court on four counts of possessing and conspiracy involving prohibited frozen goods in December last year.

It involved 5,224 boxes containing frozen chicken parts, beef, mutton, turkey and duck worth RM643,465.39.
Svarikat LY Frozen Food Sdn

Syarikat LY Frozen Food Sdn Bhd, its directors Yong Chee Keong, 40, and Tan Siew Huak,

42, who are still at large, and manager Chong Kim Kuang, 48,

pleaded not guilty to the charges. On Feb 9, the same company and executives pleaded not guilty at the Sessions Court here to 21 counts of possessing and distributing unauthorised frozen products and using false and unauthorised halal logos.

They were accused of possessing and distributing 3,418 packages of frozen products without the approval of two Australian companies and using false and unauthorised halal logos from two Australian certification bod-

Meanwhile, in Port Klang, Maqis on Friday seized four containers carrying 120,000kg of onions from India, after discrepancies were found on the import permit. Selangor Maqis director Zamri

Selangor Maqis director Zamri Hisham said the consignment, valued at RMI50,000, was seized by enforcement officers at 12.15pm.

"Maqis found that the consignment did not comply with the requirements of the 3P Certificate (Grading, Packaging and Labelling) Regulations.

"Investigations also revealed that the consignment is meant for local distribution to wholesalers."

Zamri said they had seized all four containers.

He said the failure to comply with import conditions and regulations was an offence under Section 15 (1) of the Quarantine and Examination Services Act 2011 [Act 728].

RM100 and RM30 respectively from Abdul Latif A. Rahman as an inducement to expedite the physical and document inspection of a consignment.

They were accused of committing the offence at the MAQIS office at the Sultan Abu Bakar Complex on Nov 10 and Oct 5, 2020, respectively.

He faces two alternative

charges of submitting false import document on behalf of Syarikat LY Frozen Sdn Bhd for the two offences.

The alternative charges are under Section 471 of the Penal Code and punishable under Section 465 of the same Code.

Bail for Latif, who was represented by counsel A. Vijaya, was set at RM8,000 with one surety, and mention is fixed for June 29.

Deputy public prosecutors Wan Shaharuddin Wan Ladin and Suhaili Sapun appeared for the prosecution.

OUR Malaysian Quarantine and Inspection Services Department (MAQIS) enforcement officers, along with a manager of a logistics company, were charged at the Sessions Court here over the meat cartel case.

Nor Azlan Mat Suki, 40, pleaded not guilty to five charges of receiving a total of RM35,000 as inducements to release 40 containers carrying frozen meat belonging to Syarikat ZS Armin Sdn fixed on June 29. Bhd from countries not recognised by the Veterinary Services Department (VSD).

He was accused of committing the offences between February and April 2017 at a restaurant in Iskandar Puteri.

Zahid's Foreign Visa System graft trial starts today

SHAH ALAM: The corruption trial of former deputy prime minister Datuk Seri Dr Ahmad Zahid Hamidi, who is facing 40 charges over the Foreign Visa System (VLN), will start at the High Court here today, with the prosecution set to call two or three witnesses to testify.

The trial will be heard before judge Datuk Mohd Yazid Mustafa at 9am.

"Yes, the trial will go on tomorrow (today).

"We expect to call two or three witnesses," deputy public prosecutor Datuk Raja Rozela Raja Toran, who will lead the prosecution team, said in a text message. Lawyers Hisyam Teh Poh Teik and Hamidi Mohd Noh are representing Zahid, 68.

Prior to this, Raja Rozela had informed the court that the prosecution would call 15 witnesses to

APPROVING TENDERS

Fisheries officer claims trial to bribery

KOTA BARU: A Fisheries Department officer was charged at the Sessions Court here yesterday with five counts of bribery involving RM31,425 from a company owned by his sister-in-law.

Mohd Rafi Hassan, 56, however, pleaded not guilty before judge Zaman Mohd Noor.

On the first charge, Rafi was accused of using his position as aquaculture branch chief at the Kelantan Fisheries Office to gain gratification by approving the tender to supply and deliver 1,000 grouper fry worth RM6,900 to YY Indah Enterprise, a company owned by his sister-in-law,

on Jan 22, 2019.

On the second charge, he was accused of gaining gratification when approving the tender to the same company for the supply and delivery of fish hormones worth RM7,500 to Machang Aquaculture Centre on Jan 31, 2019.

For the third charge, he was accused of gaining gratification by approving the tender for the same supplier for the supply of brine shrimps for fish worth RM15,800 on March 27, 2019.

On the fourth and fifth charges, Rafi was accused of gaining gratification by approving a tender to the same supplier for the supply of fish hormones worth RM725 on April 4, 2019 and the supply of fish food worth RM500 on April 16, 2019.

He faces a maximum of 20 years' jail and a fine of not less than five times the amount or value of the gratification, whichever is higher.

Deputy public prosecutor Nor Hamizah Ghazali prosecuted the case while the accused was represented by Cheah Poh Loon. Zaman allowed the accused to be released on a RM6,000 bail with one surety.

He set July 7 for the case to be re-mentioned.

DPP: 20 WITNESSES TO TESTIFY AGAINST ZAHID

Prosecution says it will prove how the then home minister abused his position to reap riches

HE prosecution is expected to call 20 witnesses to testify against former deputy prime minister Datuk Seri Dr Ahmad Zahid Hamidi, who is facing 40 charges over the Foreign Visa System (VLN) scandal.

Deputy public prosecutor Raja

Deputy public prosecutor Raja Datuk Rozela Raja Toran, who is leading the prosecution team, said the witnesses will be testifying under oath on how Zahid had taken advantage of his position as the then home minister to reap riches through corrupt means.

She said the prosecution would prove how Zahid had abused his position throughout his four-year tenure as home minister.

"We will show how he received bribes in various currencies, including \$\$\$14.71 million, RM3.125 million, U\$15,000 and £5,000 from Ultra Kirana Sdn Bhd (UKSR).

"UKSB was a company which was appointed by the govern-

ment as a contractor to supply and provide services for the Home Ministry," she said in her opening statement on the first day of the trial.

Later, deputy registrar at the Registrar of Companies Malaysia (SSM) Muhamad Akmaludin Abdullah, 38, who was the first prosecution witness revealed all the information regarding UKSB.

He said UKSB was a private company that engaged in the outsourcing of visa facilitation services in the country.

He added that based on records dated Sept 10, 2013, the company had four directors — Harry Lee Vul Khlun, Tan Siong Sun, Wan Quoris Wan Abdul Ghani and Fadzil

However, according to the company's Notification of Change In The Register of Directors, Managers And Secretaries form dated Jan 30, 2018, it stated that only Wan Quoris and Fadzil remained as its directors, he said.

Meanwhile, Zahid issued a press statement after the proceedings.

The statement, which was distributed by his press secretary, said Zahid denied all allegations and maintained his innocence.

and maintained his innocence.

"Zahid never received any bribes from UKSB as the appointment of UKSB was not done dur-

ing his tenure as the home minister.

"He is innocent until proven guilty," it was stated in the statement.

Zahid is on trial for 33 counts of receiving bribes amounting to \$\$13.56 million from UKSB.

The money was received as an inducement for himself in his capacity as a civil servant (then home minister) to extend the contract of a company as the operator of a One Stop Centre (OSC) in China and the VLN system as well as to maintain the agreement to supply VLN integrated

Experts say plan must be in place to redistribute vaccines of those who skipped their appointments

HILE Malaysians are scrambling to secure a slot for the As-traZeneca

vaccine, tens of thou-sands of people have failed to turn up for their jabs under the second phase of the National Covid-19 Immunisation Programme (NIP).

The current development had prompt-ed health experts to make a fresh call for the government to restrategise the NIP to enable more people who want to be vaccinated to receive their jabs

faster, and avoid the issue of vac-

More than 30,000 people had reportedly skipped their vaccina-tion appointments in Kedah, Per-ak and Kelantan since last month.

Meanwhile, all slots for the second round of the AstraZeneca vaccine voluntary opt-in programme, which opened at 12.15pm yesterday, were snapped up within 90 minutes, leaving scores of people frustrated and

fuming.
As of Tuesday, Malaysia had also recorded a boost in the num-ber of registrants for Covid-19 vaccines, with more than 11 million people, or 45.6 per cent of the

target population, under the NIP.
The tens and thousands of missed vaccine appointments could have been efficiently diverted to crisis areas, and used to inoculate high-risk individuals as cinated faster, experts said.

Epidemiologist Professor Datuk Dr Awang Bulgiba Awang Mahmud said the current devel-opment was an indication for the government to start re-strategis-ing the NIP and opt-in programme to ensure that the country was on track to achieving its herd immunity goal.

"The government really needs to re-strategise the vaccination programme. It needs to push for faster delivery of vaccines from the manufacturers." the manufacturers.

"I would strongly suggest offering the AstraZeneca vaccine to those in the high-risk group as an option in MySejahtera. This should be done as aggressively as possible," he told the New Straits Times.

He said states in dire need of vaccination due to the high incidence rates, such as Selangor, required a more aggressive way of reaching out and vaccinating people, which could be done by permitting walk-ins for instance. "In high incidence

and vaccination rates

are slow, I would advocate going to community centres, registering people on the spot and vaccinating them on the spot for those who are fit and willing to do so.
"Some of these vaccines do not

some of these vaccines do not require ultra-cold storage, so this is quite possible," said the Science, Technology and Innovation Ministry's Covid-19 Epidemiological Analysis and Strategies Task Force chairman man.

Dr Awang Bulgiba noted that there could be various reasons for registrants not turn-ing up for their appointments, like not Dr G. Jayakumar feeling well, being a

person under investigation, being unable to travel or as a result of the negative publicity sur-rounding the AstraZeneca vac-

cine.
"The only way to establish this is by cross-checking with the PUI

database and by asking those noshows themselves. This can be done via the MySejahtera app, or by calling them up or sending them a text message or an email."

Dr G. Jayakumar, professor of community and occupational medicine at Manipal University College Malaysia, said the au-thorities should relook the mechanism of registration.

Dedicated state Health Departments, he said, should be allowed to run their own vaccine regis-tration portals under the purview of the federal authority.

Jayakumar said other avenues

could also be utilised, such as post offices, places of worship, schools, malls and community centres to complement the online registration process.

He said prioritising the vaccination recipients was the way to go, especially for high-risk peo-ple, which included those above age 60, those in old folks homes prisons, detention centres, frontline media personnel and stu-dents attached to hospitals for

clinical training.
"There can be an inbuilt mechanism of a waiting period created, where a replacement may step in automatically once someone fails to turn up for their vaccina-

On the mad rush to register for the AstraZeneca vaccination and the ensuing system failure yesterday, he said better plan-

ning was needed considering the high number of applicants. "The reliability of the registra-tion system is of utmost impor-

tance. This type of platform must be given out to reliable and reputed website developers.

Elderly skipping shots for fear of side effects

KOTA BARU: Many senior citizens who did not turn up for their vaccination under the second phase of the National Covid-19 Immunisation Programme (NIP) have cited the fear of side effects as the reason for skipping their appointments.

Health Department director Datuk Dr Ding Lay Ming, Meanwhile, Bernama reported Health Minister Datuk Seri Dr Adham Baba as saying that 935,865 individuals had completed taking two doses of vaccine up to Tuesday.

He said the five states with the

highest number of people receiving both doses were Selangor (126,462), followed by Sarawak (92.261). Kuala Lumpur (90.514). Johor (83,728) and Perak (78,940).

A total of 11,069,418 individuals had registered for vaccination, with Selangor also recording the highest number at 2,916,443.

second round of the AstraZeneca Voluntary Vaccine Initiative is now closed. Those who are el-igible will receive an appointment soon.

"Thank you for your interest in helping the nation achieve herd immunity," said the Special Com-mittee on Covid-19 Vaccine Sup-

mittee on Lovid-19 vaccine sup-ply Access Guarantee (JKJAV) on its Twitter account yesterday. The committee, however, made no mention of the number of slots that had been taken up. In a separate tweet earlier, JK-JAV said over 300,000 slots were booked in less than 40 minutes

since the registration opened.

During the weekly press conference by the Covid-19 Immunisation Task Force on Tuesday, National Covid-19 Immunisation Programme (NIP) coordinating minister Khairy Jamaluddin said 1.26 million doses of the AstraZeneca vaccine would be utilised for the second round of the opt-in programme. Khairy, who is science, technol-

ogy and innovation minister, had also said 228,347 slots for the sec-ond round of vaccination had been booked by senior citizens

"Why does the website want to provoke me? I started first thing in the morning. You understand 'first ting (thing) in the morning?' (Registering for family mem-

bers)," he added

Maszlee tweeted: "I can't be-lieve I had to claim that I'm not a robot for nearly a thousand times today (yesterday)."

Another Twitter user, who identified herself as Dr Sherrini Ahmad, wrote: "I am a frontliner struggling to register my family struggling to register my family members for your vaccine thus far. My failure to do so in the last ½ hour tells me how bad (the system is). Fighting to get the vaccine like going on Boxing Day sale. Heartbreaking."

Kenneth Wong wrote: "The fact that everyone is scrambling for AZ does not mean the govern-

that everyone is scrambing for AZ does not mean the govern-ment is successful in raising awareness. It just means that the NIP has failed, being too slow and everyone is unsure how long it will take."

Another social media user named Wan Nur Syaira said: "It is not like people don't want to get vaccinated. They just can't…" A netizen known as Ratul crit-

icised the government for putting

out an "incompetent website" to book the AstraZeneca slots.
"Thousands of people missed out on the chance to book their AZ 2.0 vaccine appointments because of the incompetent registration website. Will anyone clarify why the submission and state ify, why the submission and state buttons were not working? So many people just wasted so much of their time for nothing," he

Juliana Menon wrote: "Why can't I choose the date and lo-cation? Can @JKJAVMY please be more competent?"

The frustration over the technical glitches also prompted the Malaysian United Democratic Al-

liance (Muda) to question the website's efficiency. Its secretary-general Amir Abd Hadi urged Khairy to reveal the individuals who received the

"After the website failed to meet the standard several times in facilitating the public to register for their vaccines, people have started questioning several issues, among others, the use of a free 'cloudflare'.

"Khairy must reveal who re-ceived the contract to develop this website. The people deserve to know," he said in a statement vesterday.

KUALA LUMPUR: The High Court was yesterday told that the board of directors of 1 Malaysia Development Bhd (1MDB) had put up a "big sandiwara" (charade) about the company's overseas funds, which actually belonged to Umno, from official records.

This was revealed by former IMDB chief executive officer Mohd Hazem Abdul Rahman during the trial of former prime minister Datuk Seri Najib Razak over the misappropriation of RM2.28 bil-lion funds from IMDB.

He said this when replying to questions by Najib's lawyer, Wan Aizuddin Wan Mohammed, on

Arzuddin wan Monammed, on attempts to repatriate IMDB funds purportedly invested overseas back to Malaysia in 2014.
Asked why he did not put on record about the funds belonging to Umno during a board meeting he attended on Feb. 27, 2014. he attended on Feb 27, 2014, Hazem said that it was not sup-posed to be put on the record as it

was a "scheme".

He also said that everyone on
the board knew the real purpose
of the money and whatever

recorded in the minutes of the board meeting that day was just for show.

Wan Aizuddin: Is there a reason why you said everyone (on the board) knew the money belonged to Umno and at one point you said everyone knew the real purpose of the money?

Hazem: Yes. Wan Aizuddin: Why did you not put it on record that these funds

put it on record that these funds belonged to Umno? Hazem: This is a scheme, it shouldn't be put on record. Wan Aizuddin: Now you are say-ing that this is a conspiracy that all the board members participat-

Hazem: Yes. Wan Aizuddin: So you are saying that whatever recorded in the minutes (of the board meeting) was just for show?

Hazem: They knew what was at

stake. Wan Aizuddin: Their (IMDB board members) instructions to the management to liquidate and bring back the funds is a "big sandiwara"?

Hazem: Yes. On Sept 14 last year, Hazem testified that the real purpose of the establishment of IMDB by Najib was to help Umno obtain funds through businesses involving IMDB's strategic investment. He said this was relayed to him

by fugitive businessman Low Taek Jho, or Jho Low. However, Hazem agreed with Wan Alzuddin that he had never

heard this directly from Najib himself. He said the basis of his belief

that the 1MDB funds overseas be-longed to Umno was because Jho Low and Najib's former principal Azlin Alias, had told him so.

WITNESS in Datuk Seri Dr Ahmad Zahid Hami-Dr Ahmad Zahid Hami-di's corruption trial yes-terday said the former home minister had breached the ministry's protocol when grant-ing a contract extension to a private contractor.

Former Home Ministry (Immigration Affairs) deputy secretary
Siti Jalilah Abd Manap, 49, said
Zahid did not adhere to the ministry's protocol when he extended Ultra Kirana Sdn Bhd's (UKSB)

contract involving the Foreign Visa System (VLN) project.

Jalilah, who testified as the

third prosecution witness, said Zahid penned a minute inform-ing the ministry's secretary-gen-eral not to bring the matter to the Prime Minister's Office's public private partnership unit (UKAS) or the Cabinet.

UKAS is a central agency with the role of facilitating strategic partnerships between the public and private sectors, through the Public Private Partnership programme.

She said UKSB sent a letter dated Oct 17, 2016, asking the gov-ernment to extend its contract to manage the VLN for six years be-fore the expiry of its initial con-

Jalilah said the agency then re-ceived a letter from the deputy prime minister's office dated June 16, 2017, titled Suggestion to extend VLN contract and E-Visa for another three years starting Oct 31, 2019 to Oct 31, 2022.
