RM589,450 BRIBE TO GO TO TREASURY

Bitcoin miner fined for paying bribes to cover up illegal activity

ALOR STAR: The Sessions Court here fined a rubber wholesaler RM250,000 after he admitted to a charge of paying over half a million ringgit in bribes to cover up his illegal cryptocurrency mining operation.

Judge Harmi Thamri Mohamad passed down the sentence on Th'ng Kean Kai, 33, after he pleaded guilty to the charge filed under Section 214 of the Penal Code.

The charge carries up to 10 years' imprisonment or with a fine, or both upon conviction.

The father of two had paid RM589,450 in bribes to an undercover Malaysian Anti-Corruption Commission (MACC) officer.

The bribe was paid as an inducement not to prosecute him, after the accused was caught stealing electricity to carry out illegal bitcoin mining activity.

In February last year, Tenaga Nasional Bhd (TNB) and MACC had detected an electricity theft for illegal cryptocurrency mining activity.

TNB had informed MACC that

TNB had informed MACC that the person behind the activity was willing to offer a bribe to its staff to cover up the activity.

Acting on the information, an officer with MACC was placed undercover in the TNB's special unit dealing with electricity theft.

The accused had subsequently set up the first meeting with the undercover MACC officer at Emerald Putri Hotel in Sungai Petani on Aug 26, 2021, where he paid RM42,000 as a bribe.

The next day, the accused paid another RM28,000 cash as a bribe to the undercover officer at the same hotel.

Th'ng admitted that he paid the bribes in four other separate occasions between Sept 29, 2021, and Feb 28, 2022. in Sungai Petani.
During the separate meetings, he had paid RMS/5600; RMI21,250; and RMI21,800 with the last payment worth RM94,800 made to the officer on Feb 28, 2022.
Lawyer Tengku Hezrul Anuar Tengku Abdul Samad, who represented the accused pleaded for leniency as it was his client's first offence. first offence.

"The accused is the sole bread-winner for his family. He has two young children and is also sup-porting his father who suffers from diabetes and hypertension.

Court finds him guilty of using fake documents relating to a maintenance contract 9 years ago

ORMER Sabah Infrastructure Development minister Datuk Peter Anthony, SI, has been sentenced to three years' jail and a RMSO,000 fine after he was found guilty of using false documents relating to a system maintenance

contract nine years ago. Sessions Court judge Azura Al-

wi sentenced Peter after ruling that the prosecution had proven its case beyond all reasonable doubt against the accused.

She ordered the sentence to run

She ordered the sentence to run from yesterday.
Peter would have to serve 15 more months if he failed to pay the fine.
Azura, in her judgment, sald Anthony's defence was inconsis-tent, a bare denial and an af-terthouseh. terthought,
"There is circumstantial evi-

dence and testimonies from wit

dence and testimonies from witnesses to show that you (Peter) were the only one who had the opportunity to falsify the documents," she said.

She added that Syarikat Asil Jati, owned by the accused, had gained from the forgery as the letter used received the support from Universiti Malaysia Sabah (UMS) for the contract.



This resulted in the Finance This resulted in the Finance Ministry awarding it the contract through direct negotiations for five years," she said. Peter's counsel S. Devanandan, when pleading for a minimum sentence, said his client was a

prominent politician and contributed a lot to Sabahans.

"My client had given his full cooperation during the investigation and attended every proceeding without fail." he said.

Devanandan applied for a stay of execution on Peter's jail sentence pending appeal.

2 HEALTH OFFICERS HELD OVER ALLEGED GRAFT

They allegedly raked in RM15,000 each between 2018 and 2021 for funeral arrangement services

WO assistant health officers were nabbed yesterday in an ongoing crackdown by the Malaysian Anti-Corruption Commission (MACC) against cartel soliciting and accepting bribes for funeral arrangement services.

The suspects, aged 40 and 42, were arrested at the Selangor MACC headquarters at 4.45pm on Thursday when they arrived to have their statements recorded.

It is learnt that the suspects, who are attached to a hospital in the state, allegedly solicited and accepted RM300 in kickbacks for each funeral arrangement.

It is also learnt that the suspects raked in RM15,000 each in kickbacks between 2018 and last year.

Both suspects have been remanded for five days to assist with investigations, which are being carried out under Section 17(a) of the MACC Act 2009.

The remand order until May 31 was issued by magistrate Nur Faizah Abdul Sani when the suspects were produced at the magistrate's court here yesterday.

It was reported that five employees from another hospital in the state were arrested by MACC in October last year on suspicion of soliciting and accepting bribes from agents for funeral services.

Bernama quoted an MACC source as saying that the activities were believed to have been carried out between 2019 and last year with bribes totalling more than RM20,000.

Land swapped for Penang tunnel project study valued at RM80m, court told

LAND SWAP VALUED AT RM80M

Valuation officers agree state govt did not suffer loses in deal to study Penang tunnel

HE two plots of state land swapped to offset the cost of a feasibility study for the Penang undersea tunnel were valued at a total of RM80 million.

Witnesses testifying in former Penang chief minister Lim Guan Eng's corruption trial said Lot 702 and Lot 713 in Bandar Tanjung Pinang on the island were valued at RMSO million and RM30 million respectively.

Both lots were signed away by Lim to the developer of the tunnel project and later used for the City of Dreams project by the Ewein Zenith Group.

The first witness to be called yesterday, valuation officer Zakariya Nayan, 55, said he valued Lot 702 in December 2014 based on the then market value of

RM3,360 per sq m. The second witness, Nurul Asshima Aminullah, 33, said she valued Lot 713 at RM30 million in 2016.

When cross-examined by Lim's lawyer Haijan Omar, Zakariya agreed that the value of the land was far less than the cost of work by the developer, which was estimated to be around RM138 million.

Nurul Asshima also agreed with the lawyer's suggestion that the value of Lot 713 was less than the RM73 million spent by the

developer on the project.

Both witnesses agreed that based on this, the state government did not suffer any losses in the land swap deal.

It was reported that Ewein Zenith, headed by the late Datuk Ewe Swee Kheng, had developed the billion-ringgit City of Dreams on the plots of reclaimed land. Ewein Zenith is a joint venture

Ewein Zenith is a joint venture vehicle between Ewein Land Sdn Bhd and CZBUCG Sdn Bhd. The freehold 1.49ha City of Dreams is opposite the strategically located Gurney Drive. It comprises 572 luxury seafront serviced apartments in a 39-storey twin tower. Apartments are priced upwards of RM1,500 per sq feet.

The Malaysian Anti-Corruption Commission (MACC) had detained top executives from the company in its probe into the tunnel project.

tunnel project.

The MACC was investigating why Lim's state government had pre-sold state land rights worth RM3 billion despite a four-year delay in the construction of roads, which were part of the tunnel project.

Lim, who is DAP chairman, is accused of soliciting a 10 per cent cut in profits from the tunnel project from Consortium Zenith Construction managing director Datuk Zarul Ahmad Mohd Zulkeni

He is also accused of seeking RM3.3 million in kickbacks to appoint Zarul's company to undertake the project.

He also faces two counts of dishonestly misappropriating RM208.7 million of state land to two companies.

The trial before Sessions Court judge Azura Alwi continues on June 7.
