MACC probing 25 cases of Covid-19 mismanagement

PUTRAJAYA: A total of 25 investigation papers on alleged mismanagement of Covid-19 involving various offences have been opened, says Malaysian Anti-Corruption Commission (MACC) chief commissioner Tan Sri Azam Baki.

He said the MACC would summon those involved to assist in the investigations and would also inform accordingly the developments of the cases.

"Many individuals have been and will be called as each case is different," he told reporters after launching a Journalist Empowering Programme with the MACC.

He did not rule out the possibility the cases involved various agencies, including the Health Ministry.

in the investigations, Azam said any possible
action would be taken, depending on the

On May 25, the MACC chief commissioner said corruption involving the procurement of medical equipment and medicine was uncovered during the Covid-19 pandemic. "During the pandemic, many nations were

Following the disclosure, Dr Adham said he would cooperate with the MACC.

Dr Adham, who held the portfolio when the country was facing the pandemic, admitted to having personally received such complaints, explaining that these occurred at the administrative level.

Not to let a crisis go to waste, the Not to let a crisis go to waste, the Government has emphasised on realigning growth in a sustainable trajectory, which includes restoring the growth momentum of key economic sectors, and propelling strategic and high impact industries including micro, small and medium enterprises (MSMES).

These are of vital importance as Malaysia sets its sights on becoming a high-income nation driven by advanced technology, which will see the country move towards high value-added and high-skilled conomic activities.

Against this backdrop and given the significant contribution of trade to Malaysia seconomy, the Malaysia External Trade Development Corporation (MATRADE) developed the National Trade Blueprint (NTBp). It is the first blueprint of its kind, commissioned by the International Trade and Industry Ministry (MITD). The NTBp was launched by Prime Minister Datul Seri Ismall Sabri Yaakob on Oct 25, 2021.


"NTBp outlines a five-year (2021-2025) development strategy and initiatives to einhance the nation's export competitiveness through the strengthening of the business ecosystem and to improve Malaysia's position as a landing exporting country globally in the merchandise sector," said MARADDE chiefer Modern Conferer Mold Mustafa Abdul AZZ.

This is led by four key priorities.

This is led by four key priorities, three strategic themes and eight strategic thrusts (see infographic).

Eight working groups have been formed to implement the recom-



mendations put forth by the NTBp

- Trade Facilitation; Logistics;
Standards and Conformance; Trade
Promotion and Market Access;
Sustainability and Innovation;

Promotion and Market Access; Sustainability, and Innovation; Digitalisation and Technology. Investment; and Branding. The working groups comprise relevant members from the public sector, and representatives from various ministries and agencies, the private sector, business communi-ties and trade associations.

The NTBp also leverages on the Jawatankuasa Koordinasi Export (JK-X), chaired by the Chief Secretary to the Government as the governing and supervising body on the implementation of the 40 recommendations and the 127 initiatives under the blueprint. The committee meets thrice a year.

The working groups have hit the ground running such as the logistics unit, whereby the Transport Ministry has revised the policy to

allow sharing of prime movers and trailers within the same group of

trailers within the same group of companies.

This reduces capital and operating cost by 10% to 20% to resolve the issue of high ancillary port charges, contributed by the ability of transport companies to optimise existing partnerships without having to increase the number of trailers.

Similarly, under the Trade Promotion and Market Access

working group, MATRADE is currently coordinating the development of the Single Information Portal for Export (SIPE) and Integrated Trade Events Platform (ITEP). These initiatives are to address the immediate needs arising from the pandemic to boost Malaysia's trade competitiveness. SIPE will be a comprehensive portal encompassing information across the export value chain while the provide of the portal encompassing information across the export value chain while the provided of the export promotion. The main benefits of these platforms include stronger national events; and, big data analytics, among others.

"On the whole, the NTBp serves as an important agenda for the development of Malaysia's exports, which in turn delivers a positive impact for the nation. The higher reverue from exports leads to more opportunities to improve the courty's infrastructure and facilities, Mustafa said.

The investment and business export activities are also set to generate better employment opportunities whilst spurring quality education, which is needed to provide skilled manpower and talent to meet industry needs.

It also pushes Malaysia a step closer towards a higher income nation status and improving the lives and livelihood of the people.

The success of the NTBp requires concerted feforts from both the public and private secrost to develop a conductive business ecosystem that is essential for exports to three.

Senior exec and wife remanded over bribe

PUTRAJAYA: A senior executive in a government-linked company and his wife have been remanded to help in a probe into claims that they had asked and received money totalling more than RM600,000 for appointing a transportation company to deliver goods.

The husband and wife, who are in their 50s and 40s respectively, were arrested at their home in Petaling Jaya at about 7pm on Saturday, according to sources.

They were brought before magistrate Shah Wira Abdul Halim yesterday. The court allowed for the suspects to be remanded for six days until June 10.

It is learnt that the man had demanded for a "monthly payment" of about RM20,000.

"The money is his 'reward' for appointing the transport company to deliver petroleum-based products across the country for a period between July 2019 and April this year," the sources added.

The woman is believed to be in cahoots with her husband and had asked for and accepted money on

his behalf.

It is learnt that the senior executive had been suspended from his duties at the company.

Telco CEO remanded over bribe amounting to over RM200,000

JOHOR BARU: The chief executive officer of a telecommunication company, has been arrested on suspicion of graft involving more than RM200,000 as an inducement to approve a project to build and repair telecommunication towers. Johor Malaysian Anti-Corruption Commission (MACC) director Datuk Armi Allas confirmed that the 43-year-old suspect was arrested at the Selangor MACC office at around 8pm Monday.

The suspect was brought to the Shah Alam Magistrate's Court on yesterday, where magistrate Mohamad Redza Azhar Rezali around 8pm Monday.

The suspect was said to have asked for

The suspect will be remanded until June 17 for investigations under 15 (a) (A) of the MACC Act 2009, said Azmi.

Meanwhile, Bernama reported that MACC's application to remand a senior enforcement officer and a businesswoman for four days and two days respectively from yesterday was allowed by the court.

First audit report not submitted 'due to meeting'

KUALA LUMPUR: The High Court was told the first version of an audit report on 1Malaysia Development Bhd (1MDB) dubbed "Watermark 09" would have been submitted to the Public Accounts Committee (PAC) had it not been for a meeting

(PAC) had it not been for a meeting held on Feb 24, 2016.

This was testified by former 1MDB CEO Arul Kanda Kandasamy, 46, in the 1MDB audit tampering trial involving him and former prime minister Datuk Seri Najib Razak yesterday.

In an examination-in-chief, lead

prosecutor Datuk Seri Gopal Sri Ram told the co-accused-turned-witness that there was evidence from other witnesses who testified in the

Sri Ram: You were in court listening to that evidence. Arul Kanda: Yes.

Sri Ram: Do you agree with that evidence?

Arul Kanda: Yes.

The court had previously heard of the Feb 24 "coordination meeting" held between 1MDB and other agencies, chaired by former chief secretary to the government, the late Tan Sri Ali Hamsa, at the behest

of Najib. Arul Kanda testified that he had attended the Feb 24 meeting where he first saw Watermark 09 at the

end of the meeting.

He said it was a concern during the meeting that the findings of the report (Watermark 09) "may be spun politically". Sri Ram: Spun to whose detri-

Arul Kanda: My understanding is that it would be spun towards Najib's detriment.

The witness also testified of an "unusual" meeting held at the Kiara Hills home of former TV3 CEO Datuk Seri Ahmad Farid Ridzuan, who was Najib's special officer at that time, on Dec 1, 2015.

He said former 1MDB CEO Datuk Shahrol Azral Ibrahim Halmi, former PAC chairman Datuk Hasan Arifin, and two or three PAC members were in attendance.

Sri Ram: What was the purpose of meeting at Farid's house?

Arul Kanda: (To discuss) what I would be presenting to PAC about 1MDB's affairs.

Sri Ram: Did you receive any instructions from anyone in that meeting on how you should address the PAC?

Arul Kanda: It was more of me sharing information (to them) than them telling me what to do.

Sri Ram: What was the purpose of having a meeting with Hasan? Arul Kanda: I found it unusual to

have that session with him, but I was asked to do so, and I did it.

The witness was also asked about the roadshows or "ceramah" he conducted as instructed by Najib before the 14th General Eleaction in

"He (Najib) wanted me to explain 1MDB, the issues the company faces, the rationalisation plans," he

Arul Kanda said he would use a Arul Kanda said he would use a PowerPoint presentation to deliver his "ceramah" and defend 1MDB's interest as well as field both "sup-portive and non-supportive" ques-tions from the public when it came to Naiib.

To the questions on Najib from the public, Arul Kanda said he would be answering them based on statements by the then-Attorney General (that exonerated Najib) and the Malaysian Anti-Corruption Commission

"Typically, what I would do, I would invite the audience to come

would invite the audience to come up with their conclusions.

"The phrase I usually say is 'terpulang kepada tuan-tuan dan puanpuan untuk buat keputusan sewajarnya' (it is up to you, ladies and gentlemen, to decide).

"I do recall using that phrase quite a bit," he added.

Garlier in the proceedings, High Court judge Justice Mohamed Zaini Mazlan allowed an application by the prosecution to call Arul Kanda to testify as a prosecution witness under Section 63 of the Malaysian Anti-Corruption (MACC) Act 2009. Commission

The judge said he was satisfied with the prosecution's grounds for the application and that there was no hindrance to the application at any stage in the prosecution's case.

Najib, 69, is accused of abusing his position to order amendments to the 1MDB final audit report to avoid any action against him, while Arul Kanda is accused of abetting

Najib in making the amendments. Both men face charges under Section 23(1) of the Malaysian Anti-Section 23(1) of the Maiaystan Anti-corruption Commission (MACC) Act 2009, which provides a jail term of up to 20 years and a fine of no less than five times the amount of grati-fication or RM10,000, whichever is

higher, upon conviction. The hearing resumes on July 4.
